rudents being dropped off after the start of the school day must report to their class on time. No excused absences will be even for arriving to school late.		
Students must follow all school check in and check out procedures. Students are not permitted to loiter on campus during these respective periods and may face disciplinary consequences		
of statements for loitering. Ex: If a student is taking an online class off campus 6th period, the student should leave campus at the end of 5th period. If a student is taking an online class off campus in 1st period, he/she should arrive to school in time for 2nd period to start.
