

DUAL ENROLLMENT PROGRAM AT CENTENNIAL AT CENTENNIAL HIGH SCHOOL 2013-14

Description: Dual Enrollment (DE) is a program in which a student takes college courses at the same time they take high school courses. Students can take DE three ways:

1. College courses taken at Centennial HS:
 - A. College English 1101, 1102, with credit from Georgia Perimeter College (GPC). The class is taught at Centennial by a Professor from GPC.
 - B. Calculus II and III through a Distance Learning course from Georgia Tech.
2. #Full time courses at a college campus (take all courses on the college campus – see MOWR).
3. #Courses at Centennial and on a college campus.

For courses at Centennial:

College English is 8:15am-9:30am two days per week (Monday & Wednesday or Tuesday & Thursday). Afternoon sections could be added if the number of students exceeds the maximum for class size in the morning. The time would be 2:45pm-4:15pm. Calculus is 8:05am-9:00am Monday through Friday.

Both courses are considered first period (students required to take 6 courses/semester).

Students will receive a grade at the end of the semester only (no Progress Report grades). Classes are run as if on the college campus therefore Centennial is not involved in decisions made in the class. It is the responsibility of the student to complete all required work to receive a grade. Students must attain a Centennial High School grade of “C” or better during the first semester to continue in the class for the second semester.

Requirements for acceptance to College English/Georgia Perimeter College:

(Minimums do not mean acceptance. The college will accept students based on overall performance and not just one item).

A 3.0 GPA non-weighted and recalculated (by GPC) average in Core subjects (minimum).

SAT – For College English - 480 Critical Reading, 440 Math (minimum). If a math course is taken at GPC a 530 in the math is required (minimum). **Last SAT to be eligible is March 9, 2013 (February 8 registration deadline).**

ACT – 23 English, 18 Math, 20 composite (minimum). **Last ACT to be eligible is April 13, 2013 (March 8 deadline).**

Georgia Tech Calculus (the numbers were as of the academic year 2012).

SAT – >1300 CR+Math (minimum; this does not indicate acceptance)

ACT – 26-28 Composite (minimum; this does not indicate acceptance)

and/or

AP Calculus AB students must have a 5 in the AP exam

AP Calculus BC must have a 3 or better in the AP exam.

To apply for Dual Enrollment to GPC:

Applications should be completed online. We recommend you see your counselor before making an application.

Applications must be made Online through www.GACollege411.org. Designate the Dunwoody campus for College English. **A Parent Consent Form (included in the application) must also be completed.

Transcripts should be requested from the Counseling Office at Centennial. All transcripts must come from the Counseling Office to be official. See your Counselor or Mrs. White (Counseling Assistant) for additional directions on sending a transcript.

**The student must provide GPC with an original immunization form. Counseling Office copies are not acceptable. See your physician or a Health Clinic for an updated copy. Make sure your name and Social Security number are on the form. Read the Immunization information on the GPC application.

**Parent Consent Form and Immunization Forms are required for acceptance.

College English applications must be completed by March 8, 2013.

For Georgia Tech Distance Learning Calculus:

Apply online. Go to www.admiss.gatech.edu/dcp. Transcripts are not required but applicants must complete the admission application with HS courses/grades listed.

Calculus applications/materials must be completed and submitted to GT by April 5, 2013. Check the GT website for updates and/or changes.

Payment:

Dual Enrollment courses considered CORE courses are paid by ACCEL or Move On When Ready (MOWR). When paid by ACCEL and MOWR those credits will not count toward the total number of college credits paid by HOPE. Students taking a class at GPC may receive a stipend for books (depending on state budget).

Fulltime/part-time DE students who choose to take non-core courses (at GPC or any other college, e.g. Art, Physical Ed., etc.) are responsible for the cost of those courses.

#You must see and have the approval of your counselor for full or part time since there is a different application process. Other campuses students have taken courses are Georgia State U., Agnes Scott College, Kennesaw State, West Georgia (Academy), Middle Georgia College (Academy), and Georgia Southern.
