What Is Dual Enrollment?



- Dual enrollment provides qualified high school students with the opportunity to earn college credit while still enrolled in high school
- Students may choose to take college courses
 - At CHS: College English, College Math
 - On the college campus
 - At CHS and on the college campus (consider travel/traffic!)
- Funding sources
 - Accel: Covers tuition for core academic courses (student fees and book costs are the responsibility of the student)
 - MOWR: Covers tuition; requires full-time college enrollment
- Dual Enrollment vs. AP

Course Details



- College English – GA Perimeter College
 - 2 semester (year-long) commitment
 - This year, meets MW or TT from 8:15 – 9:30 with instructor from GPC at CHS
 - Three college credits and one high school credit earned per term for successful completion
 - College credit is potentially transferable to other institutions
 - Must maintain a “C” or better average
 - Grade Conversion
 - ✦ $A = 95 + 7 = 102$
 - ✦ $B = 85 + 7 = 92$
 - ✦ $C = 75 + 7 = 82$
 - ✦ $D = 70$ (no additional points)

Course Details



- **College Math – GA Tech**
 - 2 semester (year-long) commitment
 - This year, meets daily from 8:05 – 9:00 in digital/distance learning lab at CHS (GA Tech instructor is live at GA Tech)
 - Four college credits and one high school credit earned per term for successful completion
 - College credit is potentially transferable to other institutions
 - Grade conversion same as GA Perimeter

Course Details



- **Other Courses / Other Colleges**
 - Options depend on school and type of dual enrollment program
 - Courses typically must count toward the student's high school graduation requirements and meet the school system's graduation unit requirements
 - Full-time enrollment is 12-15 semester hours (or up to 5 high school credits in one term)
 - College credit is potentially transferable to other institutions
 - Grade conversion is typically the same as with dual enrollment courses housed at Centennial
 - Student will be responsible for scheduling of courses and for all costs related to parking, transportation, meals, etc.

What Are The Admission Requirements?



- Georgia Perimeter College / College English
<http://depts.gpc.edu/dualenrollment>
 - Minimum unweighted GPA of 3.0 in core classes
 - Minimum SAT score of 970 CR+M or ACT 20 composite
 - Minimum SAT CR 480 and Math 440 or ACT English 20 Math 18
 - Minimums do not guarantee acceptance
 - Minimums are subject to change

What Are The Admission Requirements?



- Georgia Tech / College Calculus
<http://www.admission.gatech.edu/distancecalculus>
 - Score of 4 or better on AP Calc. AB exam or score of 3 or better on AP Calc. BC exam
 - Overall GPA of 3.5 or higher on GA Tech's recalculated scale
 - Math GPA of 3.5 or higher on GA Tech's recalculated scale
 - Mid-50% SAT: 2000-2250
 - Mid-50% ACT: 30-33
 - Mid-50% GPA (recalculated on GT scale): 3.9-4.2
 - Admission is a *competitive review process*
 - Requirements are subject to change

What Are The Admission Requirements?



- **Other Colleges**
 - Vary by institution
 - Consult college's dual enrollment website for more information

Application Completion



- Complete actual college application [online](#) requesting dual enrollment status
- Submit official high school transcript
 - Use *Dual Enrollment Intent Form* to make request
 - Submit form directly to Ms. White in the Counseling Office (10-day notice required)
 - Additional instructions will be given when form is submitted
- Submit official SAT/ACT scores
 - Must be requested directly from test agency
 - Must take one or both tests by the March/April test dates

Application Completion



- Submit current, original certificate of immunization (copy from the high school will not be accepted)
- Must be registered with Selective Service if an 18+ year-old male
- Additional items as requested, such as
 - Parental Consent Form
 - Verification of Lawful Presence
- Submit application fee
- Adhere to deadlines
 - Intent form submission deadline is March 28, 2014
 - **Application submission deadline is March 30, 2014** (deadline may vary for GA Tech Distance Calculus program)

After Acceptance...



- Provide a copy of acceptance letter to Counseling Office
- Counselor must approve courses for off-campus part- or full-time dual enrollment
- Apply for Funding: Appropriate application (Accel, MOWR, etc.) must be completed and approved each semester of participation. Failure to apply for funding in a timely manner may result in receiving a bill for tuition. Remember that costs other than tuition for approved courses are often solely the responsibility of the student.
