- 4. Complete the online form
- 5. Give consent for your transcript records to be released to the college
- 6. Complete and submit
 - Transcript requests will be processed within 10 school days from when the request is received
 - It is the student's responsibility to check their MOWR application status to confirm the transcript has been received.
 - If the college has not received your transcript by the 10th business day of this request, please contact Mrs. White in the counseling office.

Official SAT, ACT or ACCUPLACER Scores

SAT or ACT:

- Standardized Test Scores must be requested online from the College Board (<u>www.collegeboard.org</u>) or ACT (<u>www.act.org</u>)
- Log on to the account you used to register for the test and submit request for your scores to be released to the college

ACCUPLACER:

- Students cannot take the test until they have submitted Gwinnett Tech MOWR application
- The ACCUPLACER is offered at the Gwinnett Tech campus. Contact the college at <u>dualenrollment@gwinnetttech.edu</u> to set up your testing appointment. Photo ID is required.
- Centennial will have ACCUPLACER testing opportunities on CHS campus in the spring. Contact the CHS counseling office or visit <u>www.mycentennialcounseling.com</u> for information
- MOWR students can retest 1 time per section per semester. Student must wait at least 14 days to retest.
