



# Move On When Ready Night



Move On When Ready is Georgia's dual enrollment program which provides HS students the opportunity to take college level coursework for credit which can be applied towards both high school and college graduation requirements.







## **MOWR Eligibility**

#### Who can participate in MOWR?

- Students enrolled in a GA public or private high school
- Students in grades 9th, 10th, 11th and 12th grade
- Students who meet the MOWR admissions requirements at selected postsecondary institution
- Students who meet high school requirements specific to Fulton County.
- Must not have already received a high school diploma
- No residency or citizenship requirement



# How much does it cost students to participate in MOWR?




The GA Student Finance Commission covers the cost of tuition, mandatory fees and textbooks for approved classes (students must meet all MOWR eligibility requirements)

The postsecondary institution cannot charge the student any additional tuition or mandatory fee costs for approved MOWR courses

Credit Hours paid for by MOWR are not counted toward the Attempted Hours or Combined Attempted Hours limit for HOPE and Zell Miller Scholarship at the postsecondary level What college classes are approved for MOWR?

\*Each college has different course offerings approved for MOWR.



Students can take courses in areas including:

Core subjects: English, math, science, social studies, & foreign language

Career, technical, agricultural and elective courses

**Online courses** 

\*Courses available to each student will vary depending on grade level and college course pre-requisites.

# MOWR Courses for Centennial Students: On CHS Campus

### **College English**

- Taken thru GA State University Perimeter College
- College professor comes to CHS to teach the course
- Class meets two days a week from 8:00-9:15am (Mon/Wed or Tues/Thurs)
- Satisfies Senior English graduation requirement

### **College Calculus**

- Taken thru GA Tech
- Students participate in course via internet feed from Polycom system
- Class meets 5 days a week from 8:00– 9:00am
- (Mon–Thurs) Student must have completed AP Calculus BC

# MOWR Courses for Centennial Students: <u>On the College Campus</u>

### **Part Time**

- Less than12 college credit hours
- Blend of MOWR classes on the college campus and HS classes at Centennial
- Schedule must have a total of 6 classes
- Need to coordinate MOWR courses with periods CHS classes are offered

### **Full Time**

- Total of 12-15 college credit hours
- All classes are taken on the college campus
- No courses would be taken at CHS
- Student is still enrolled at CHS and can participate in CHS sports, extra curricular activities, clubs and events.

### What type of student is a good fit for MOWR?

- Can articulate why he/she is interested in MOWR
- Meets college MOWR admissions requirements
- Can follow through on multi-step tasks
- Self-motivated
- Self-starter
- Mature
- Organized
- Takes initiative
- Responsible
- Has a specific pathway planned for graduation
- Can overcome any logistical challenges to traveling to and from the local high school and college\*
  - \*Transportation to and from Gwinnett Tech will be provided by Fulton County for the 2017-18 school year

#### Step 1: Meet

• with your counselor to determine if MOWR is a good fit for you and that you meet the college admission requirements.



#### Step 2: Complete

 and submit the college's online MOWR application <u>and the</u> <u>Fulton County MOWR Contract</u> for the by March 31 deadline.

### Step 3: Submit

 all supplemental documents required by the college by the May 1 deadline.

### <u>Step 4</u>: Admission

# Once students are accepted by the college....

- College will provide HS with final list of accepted students (May/June)
- Student will be notified by the college

\*<u>NOTE</u>: No MOWR classes will be added to student course requests or verification forms during the spring registration period.

#### **<u>Step 5</u>**: Complete Paperwork & Funding Application

- Student/School Counselor complete the Fulton County Schools MOWR Contract
- Student completes the MOWR application on GA Futures website to receive funding for tuition

#### <u>Step 6</u>: On the College campus:

- Student attends any required orientations for the college
- Student registers for their classes on their Participation Agreement at the college
- Student will send the MOWR coordinator/counselor a copy of their college schedule

#### <u>Step 7</u>: On the HS campus:

- MOWR coordinator will assign the student to the college class(es) on their Participation Agreement.
- MOWR coordinator will send the on-campus class rosters to the college.
- Student receives paperwork from the college to get textbooks from college bookstore

#### **MOWR Student Support and Transition**

#### School Counselor/Counseling Dept.

- Informs students/parents about MOWR
- Meets with students/parents interested in MOWR
  - Helps determine if student is a good fit for MOWR participation.
- Advises student mapping out MOWR and HS coursework, next steps and meeting deadlines
- Works with student/family after the student has completed the college application and the GA Futures MOWR Student Application

#### College MOWR Representative/Staff

- Communicates with School counselor as needed.
- Answers questions about the college application process
- Reviews application for admission and determines if student qualifies for MOWR
- Reviews MOWR & HS coursework and registers the student for college courses
- Works with student after the student has completed the GA Futures MOWR Student Application to pay for coursework

What are the expectations of students in MOWR?

Remember you are a high school student <u>and</u> a college student

#### MOWR Students are expected to....

Complete the application process themselves

Meet deadlines for both the high school/Fulton County school district and the college

Maintain communication with Centennial clubs, athletics, senior class activities, events, etc. Communicate directly with the college with questions about MOWR application, registration, classes, grades, etc.

#### Check college email account regularly

\*communication between the college and the MOWR student is primarily done via email

### Check CHS and personal email account regularly

\*communication between with the CHS MOWR coordinator is primarily done via email account student provides The MOWR Program from the Student Perspective
