<u>Registration</u>: Online through Fulton County Extended Learning portal at http://tinyurl.com/fultonsummer; direct link to registration form at http://tinyurl.com/2013registrationform.

<u>Course Offerings and Options</u>: Students have multiple options for gaining or recovering credit. Course offerings and options may be reviewed at http://tinyurl.com/2013courseofferings or via the primary link noted above. Students may register for up to two courses.

- Face-to-Face Courses allow students to choose <u>one</u> of a limited selection of half-credit courses to take in a traditional classroom setting during a 3-hour session (9:30 12:30) for 6 weeks. The courses will be held at **North Springs High School** (bus transportation from Centennial provided).
- Virtual Courses (Fulton Virtual, Georgia Virtual) provide additional flexibility with more courses offered, and students may choose to go to North Springs High School for access to computers and teachers with content expertise (bus transportation from Centennial provided, 3 hour session from 9:30 12:30 daily), or students may choose to take the course without physically attending the summer site.
- Please note that only Fulton-approved GA Virtual courses (<u>see course offerings</u>) meet the criteria for
 registration via the procedure below and for the \$225 per half-credit tuition cost. Please contact your counselor
 prior to May 24 for registration details if you wish to take a GAVS course that is <u>not</u> on the approved list.

PROCEDURE

- 1. Submit the Summer School Registration <u>REQUEST</u> Form online at <u>http://tinyurl.com/2013registrationform</u> or via the primary link noted above to indicate contact information and class preferences.
- 2. Obtain course <u>APPROVAL</u> from your counselor. This occurs automatically if you are registering for Face-to-Face or Fulton Virtual courses. If you are registering for a Fulton-approved GA Virtual course, you will need to follow the instructions for <u>GAVS registration</u> at http://tinyurl.com/GAVSregistration or at the primary link noted above after completing step 1. Please allow 3-4 business days from the time when you submit your course request (via registration form or GAVS process) for approval and notification.
- 3. <u>PAY</u> for approved course(s). Once your courses are approved, you will receive an e-mail with instructions for making your tuition payment. Once you complete these steps and make payment, you will be enrolled in your course(s) and receive a welcome e-mail with any relevant face-to-face site or FVS/GAVS log-in and orientation details. Payment instructions for summer school will begin to be emailed on or around May 1st.
