1. **ELIGIBILITY:** The Unigo.com Top Ten List Scholarship Scholarship Program is open only to those legal residents of the fifty (50) United States and the District of Columbia who are thirteen (13) years of age or older at the time of application and who are currently enrolled (or enroll no later than the fall of 2021) in an accredited post-secondary institution of higher learning (college, university or trade school). Current employees, officers, directors and agents of Sponsor and its related companies and members of their immediate families (defined as spouse, parents, siblings and children) and persons residing at the same address are not eligible to win.
